Sub:- Dr NTR UHS - PG (Medical) Admissions - Conduct of **Phase-I** web Based counselling for **Non-Service** - Competent Authority Quota (CQ) admissions into PG Medical courses for the academic year 2024-25 - certain instructions - Issued - Reg.

I am to inform you that the Phase-I counselling for admissions into PG(Medical) courses of Competent Authority Quota for **Non-service** seats was completed on **27-11-2024** and candidates have to report at the respective Medical Colleges on or before **03.00 PM on 04-12-2024**.

In this regard you are directed to constitute a "Committee" consisting of 2 or 3 Professors and Principal as chairman of the Committee shall arrange to verify the Original certificates of the Candidates before completing the process of admission. All the Original certificates must be verified very carefully and any discrepancies must be brought to the notice of University immediately. Further, I also request you to verify more particularly the local area i.e., AU/SVU/APNL and NEET cut-off score as per the Category of the candidate.

The "Committee" to be constituted at the colleges should verify the print outs of

- (1) Online Application form
- (2) Provisional Allotment Order
- (3) Original certificates of the candidates

Any deviation should be brought to the University notice immediately. Please observe remarks if any on the provisional verification form before admitting the candidate.

The list of documents to be verified at the time of admission is specified vide Annexure-I and please follow the instructions given vide Annexure-II.

Further, I request you to freeze the data of Not Reported/Reported candidates by 04.00 PM on 04-12-2024 duly following the instructions of the Service Provider.

TUITION FEE: The following is the Tuition fee structure for the academic year 2024-25 to be payable for the Competent Authority Quota seats in Private Un-aided Medical Colleges as per G.O.Rt.No.504, HM & FW (C1) Department, dated 06-08-2024 of Government of Andhra Pradesh subject to the outcome of the W.P.Nos.32975, 33162 & 35090 of 2022.

While admitting the candidates, the following guidelines are to be followed:

- 1. The selected candidates can download the provisional allotment order on payment of University Fee of **Rs.23,600/-** through payment gateway and report to the Principal of the Allotted College on or before **03.00 PM on 04-12-2024**.
- 2. The selected candidates shall produce all the Original certificates, pay the Tuition fee, necessary bonds etc., and complete the process of admission. If the candidate does not fulfil the criteria as per regulations to complete the admission process in the specified dates of admission, their admission will be cancelled automatically.
- 3. The verification of original certificates will be conducted at the time of admission in the respective College and in case of any discrepancy, the Provisional allotment will be cancelled and action will be initiated.
- 4. As per G.O.Ms.No.251, HM&FW (C1) Dept., dt.02-10-2022 each Non-service candidate admitted into PG (Medical) course in Competent Authority Quota seats in Government Medical Colleges/Private Medical Colleges shall execute a bond to serve the Government of Andhra Pradesh compulsorily in APVVP/DME, A.P Hospitals for a period of one year after completion of PG(Medical) Degree course. If they violate the bond condition either by not joining or by not completing the stipulated service period of one year within a maximum period of 18 months after completion of the PG (Medical) Degree course, a penalty of Rs.40,00,000/- (Rupees forty lakhs only) on PG (Medical) Degree candidates shall be levied. The Principals are informed to obtain a bond in the prescribed proforma which is enclosed herewith (Annexure-A).
- 5. Principals are requested to ensure that an allotted candidate can report at any one college/course either in CQ or MQ in case the candidate got seat in both CQ & MQ of Phase-I counselling. The Principals are requested to honour the decision of the candidate in choosing the allotted seat of admission. There shall not be any dual reporting of any candidate in CQ & MQ at different/same colleges.
- 5. The University fee once paid shall not be refunded under any circumstances.

Note: KEEPING IN VIEW OF LIMITED TIME AVAILABLE FOR COMPLETING THE COUNSELLING AS PER THE NMC, NEW DELHI SCHEDULE, IT IS INFORMED THAT SUNDAYS AND PUBLIC HOLIDAYS ARE TO BE TREATED AS WORKING DAYS. PLEASE INSTRUCT THE CONCERNED STAFF ACCORDINGLY.
